Take note of the following:

1. You are responsible for erecting and taking down your stall and an electrical extension cord if required.
2. You may **ONLY** sell the products listed above (subject to approval by committee) and do not form part of products that are not allowed (as mentioned below). Disregarding this may result in a ban on exhibiting and forfeiting your fees.
3. Stall fees are: **R680.00** (4X4 meters) / **R 1 200.00** (4X6 meters corner stand) per stall.
4. Follow the following procedure:
 - a. Complete this form or the electronic application form on the website
 - b. Indicate your choice of a stall (give a second and third option as applications are handled on a "First come, first serve" basis)
 - c. You will receive an email in which you will be informed whether your application was successful or not, as well as information about the payment.
 - d. Payment must be made in full within 5 days after receiving the email. If not, the stall will be made available to other applicants. Please do not make a payment before you have received confirmation that your application was successful.
 - e. You will receive an email when payment was confirmed. A printed copy of the email must be presented on arrival to gain access. Access to the venue is free for approved exhibitors.
5. Applications close on **22 May 2019**.
6. No vehicles may park between the exhibitors. You may download your products and then park in the designated parking area.
7. Approved exhibitors may erect their stalls on Friday 29 May (at your own risk as there is no security for the stalls on Friday night.) No exhibitors may sleep on the premises. For information about accommodation, please visit our website: www.proedieberg.co.za. Please keep within the boundaries of your allocated area. The festival opens on Saturday at 06:00.
